

Trane Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility.** Trane Sweepstakes (“Sweepstakes”) is open only to contractors, engineers and potential end users of Trane products (building owners, facility managers, superintendents and C-suites) that are legal residents of the United States or Canada (excluding Quebec) and are eighteen (18) years of age at the time of entry (an “Entrant”). Void where prohibited. Employees of HMI Performance Incentives or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. - 4. Enter.** During the Sweepstakes Entry Period, receive an email from the Sponsor that invites them to webpage and there complete the survey by providing your name, company name, company email

address and phone number. Once you complete the survey you will have one opportunity to play the spin2win game. There is no cost associated with completing the survey or playing the spin2win game.

Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's entries and that participant may be disqualified.
